FOR RENEWAL OF YOUR DRIVER CARD

- If you want to change your photograph, submit a new passport-size photograph (signed on the back by a Garda) and have the Garda complete section **6** of this application form. The photo should have a plain white or grey background.
- €60 payment. Enter your credit or debit card details in section **9** of this form. Cash, postal orders, cheques or bank drafts are **not** accepted methods of payment.
- If you are the holder of a non-Irish EU driving licence, you need to submit a photocopy of your valid driving licence and proof of residence – see **Proof of residence** on page 2.

FOR REPLACEMENT OF YOUR DRIVER CARD

- If your existing card was damaged or malfunctioning, please attach the card and supply details in section **5 (B)**.

FOR EXCHANGING AN EXISTING VALID DRIVER CARD

- Complete sections **1, 2, 3, 4, 6, 7, 8** and **9** in BLOCK capitals and in **black** ink. Remember to sign the Declaration at section **7**.
- Clear photocopy of front and back of valid driving licence.

- €60 payment. Enter your credit or debit card details in section **9** of this form. Cash, postal orders, cheques or bank drafts are **not** accepted methods of payment.
- Passport-size photograph (signed on back by Garda) – see sections **6** and **7**. The photo should have a plain white or grey background.
- If you are the holder of a non-Irish EU driving licence, submit proof of residence – see **Proof of residence** on page 2.

Proof of residence

You need to provide proof of residence in the following cases:

- You are the holder of an EU driving licence other than an Irish one; or
- You are applying for renewal of an existing Irish Driver Card and you currently hold an EU driving licence other than an Irish one.

Proof of residence can be a photocopy of:

- A PPSN letter issued to you at your current address by the Department of Social Protection and dated within three months of your application; or
- A utility bill (electricity, gas or phone) or a bank statement issued to you at your current address and dated within three months of your application.

Supplying a photograph

If you are applying for your **first Digital Tachograph Driver Card**, you must provide a passport-size photograph signed and witnessed by a Garda. The Garda must also witness your signature – see sections 6 and 7 of this form. The Garda must stamp the form with the station stamp and this must be dated within three months of your application. The photo should have a plain white or grey background.

When you are **renewing** or **replacing** an existing Driver Card, you don't have to supply a new photograph, but you can if you want to. The photograph must be passport-size, must have a plain white or grey background, and must be witnessed and signed on the back by a Garda – see sections 6 and 7 of this form. The new photograph you provide will replace the one held on your file and shown on your Driver Card.

Payment

When the application is submitted by post, the fee for a Digital Tachograph Driver Card is €60. Please complete the credit or debit card payment instruction (see section 9 of this form). Cash, cheques and postal orders are **not** acceptable methods of payment.

When the application is submitted online, the fee for a Digital Tachograph Driver Card is €45. For more information about making your application online, see www.rsa.ie.

Processing

You will not be issued with a receipt for this application, but if your application is successful, you should receive your Digital Tachograph Driver Card within two to three weeks. If your application is incomplete or invalid, it will be returned to you immediately.

Please ensure that you allow adequate time for your application to be processed.

If you apply online, you will receive an email to acknowledge receipt of the €45 fee and to confirm that your application is being processed. Note that online applications have a faster turnaround time.

Data Protection

Please note that all of the information requested on this form is necessary for the purposes of processing your application for a digital tachograph card. If you fail to answer any of the questions set out in the application form, it will not be possible to process your application for a card.

The details set out in your application form will be processed by the RSA and/or its service providers solely for the purposes of processing your application and, where your application is successful, for our ongoing dealings with you in respect of your digital tachograph card. Your details may also be processed for statistical purposes. These statistics are used in such a way that individual applicants cannot be identified.

The RSA will process your details in accordance with its obligations under the Data Protection Acts 1988 and 2003. This includes taking all reasonable steps (including appropriate technical and organisational security measures) to protect personal data.

The RSA may disclose personal data to its agents, contractors and service providers to the extent reasonably required for the purposes described above where we choose to have certain services provided by third parties. Where third parties are used, we do so in accordance with applicable law and take reasonable precautions regarding the practices employed by the service provider to protect personal information.

In addition to third party service providers, we may disclose personal data to An Garda Síochána, other road transport authorities and transport enforcement agencies in other EU member states or AETR states where permitted or required by law.

You have the right, subject to certain exemptions, to obtain a copy of any personal data which the RSA holds about you and to correct any inaccuracies in such data. If you wish to avail of any of these rights, please contact us at the address below. Your request will be dealt with as soon as possible and in any event no longer than 40 days after your request.

The RSA may occasionally update this notice. We encourage you to periodically review the Data Protection notice to stay informed about how we handle the personal data we collect in relation to applications for digital tachograph cards.


